日程と報告題名一覧

会議の全体像の把握、そして関係論文の検索のために、各セッションでの報告題名を原文で掲載 する。

但し、この報告題名リストもいささか複雑である。(1)当初の報告予定プログラムが小冊子とされ、またウエッブ・サイトにもかかげられた。3月はじめにこれはなおサイトに掲載されている。(2)その後、会議直前に、欠席その他によって会議内容の一部に変更があった。このプログラムはウエッブサイトにだけ報告者のフルペーパーないしアブストラクトとともに示された。これはサイトにはない。(3)実際の会議では、(2)の直前プログラムに対しても、欠席等や推定で30から40ー特に途上国から一の報告者に欠席があった。またセッションの移動等による変更があった。正確にはこのプログラムも既にない。(4)会議後に、実際に運ばれたプログラムではなく、各報告をテーマ別に編集したプログラムが、ディスカッサントのペーパーも新たに付け加えられて、ウエッブサイトに掲載されている。すなわち、実際の会議では、招待セッションは、テーマをほぼ曜日別に配分して構成されたが、寄稿セッションは、類似テーマが火曜日から木曜日の様々の時間帯に分散された(これらのテーマの同一性は、セッションの番号・符号に示されている)。これら数日にわたった寄稿報告セッションがまとめて提示されているのである。例えば、ジェンダー問題に関する火曜日と水曜日のセッションが一括されている。しかし、司会者は火曜日と水曜日で異なっているのであるが、火曜日の司会者で一括されている。

以下では、日程順(chronological)に、実際に行われたと考えられるプログラム(3)に相当する(近い)ものを示す。

この日程別プログラムは、実際の会議の進行を示すのだが、報告内容をてっとりばやく知ろうとする読者にとっては、同一あるいは類似テーマが数日に分散して、使いにくいかもしれない。

そこでテーマの番号・符号にそっての案内を独自に作成してみた。中くくりの全体的テーマの下に,個々のセッションがあり,各セッションはタイトルを持っている以下では,日付け(曜日),中くくりのテーマ,このテーマの時間帯,当該セッションの時間,当該セッションのタイトルに続いて,司会者,報告者,討論者の順に示されている。
